### DMT renames subsidiaries

**Essen, Germany, 01.09.2014. From 1st September 2014 IMC Group Consulting Ltd. (IMC GCL), the British subsidiary of DMT, will trade under the name "DMT Consulting Ltd". Likewise as of 01.09.2014 the Essen based subsidiary IMC Montan Consulting GmbH will be renamed "DMT Consulting GmbH". Together with other companies in the DMT group, including their Indian sister "DMT Consulting Private Limited" which changed its name from IMC-SRG Consulting Private Limited at the end of July, they form DMT's "International Mining Consulting" division.**

"In recent years the DMT group has expanded at international level" explains Prof. Dr. Eiko Räkera, CEO at DMT. "We feel the renaming is a necessary step to ensure that our customers recognise us as a group and to maintain a consistent image as part of our one-brand strategy".
